# Reporting Requirements Now Include Community Coaching

OCT recently passed a motion to amend Bylaw 31.01 (a) to read:

A member shall notify the Registrar in writing or in another form acceptable to the Registrar of the following:

(a) the member's business address(es) and telephone number(s) where the member is employed as a teacher and/or in which the member is in a position of trust or authority over children or students or in education.

This will require members to submit business addresses and phone numbers for any voluntary positions, such as community coaching or service clubs such as Scouts, Girl Guides etc.

On another note, the OCT finds its budget under strain and is looking to increase the member fee from \$138 to \$150 in 2014. **Money well spent!**
