2010-11	2015-16

## **Negotiations On Horizon!**Local OSSTF Begins Process

Many teachers will have breathed a sigh of relief at the results of the recent provincial election. However, the implications for collective bargaining are not yet clear. Whether negotiations will be taking place at the provincial level, at the local level, or at both levels remains to be determined. We will know more when the government once again turns its attention to the education sector.

In the meantime, at the local level we are in the process of forming the TBU Collective Bargaining Committee (CBC). A call for applications for positions on the committee will be going out on October 19th. The CBC will begin to meet in mid-November. One of its first jobs will be to gather information from all Halton secondary teachers, so that when the committee sets its priorities for bargaining, we can be confident that those priorities and bargaining positions accurately reflect the wants and needs of the Union membership.

A Collective Bargaining Committee's strength is dependent on the input and support it receives from the membership. For the Board to listen, the CBC must speak with your collective voice. Within the next few months, the CBC will be asking you to tell us what you would like to see in your new contract. When that time comes, please do your part and respond.

## **Contract Limits Teachers' On-Calls and Supervisions**

For the 2011-12 school year, full-time teachers are responsible for a maximum of 50 half-periods of Additional Professional Assignments (APAs), of which a maximum of 24 may be used for on-calls. Part-time teachers' APAs are pro-rated.

Supervisions and on-calls are to be distributed equitably among all teachers. Teachers should not receive more than one APA in a day. In the course of a week, the APA limits are two half-periods **or** three quarter periods **or** one half-period and one quarter period.

If the above limits are exceeded, you should bring the matter to the attention of your administrator (who may simply have made an error) and your Branch President. Recurring violations of the above limits should be brought to the attention of the District Office as soon as possible.
