Health and Safety Committee rolls out School Rep Training

Health and Safety Level 1 and 2

Starting Wednesday September 30 at our office. At this time we have 17 workers enrolled in the thirty hour course which will run for five evenings in the fall and five evenings in the winter. The course is a basic introduction to WSIB and gives the attending members tools to deal with assisting member in the claims process.

Eastern Ontario Fall Labour School

The fall labour school takes place during November in Picton. We have enrolled ten of our Health and Safety Representatives to the fall labour school.

The five day school offers courses in health and safety and WSIB issues. This is the largest group that our bargaining unit has sent to the labour school.

Timetabling Look-Fors:

As timetables for September are firmed up, Branch Presidents and teachers should be aware of the following Article 18 workload provisions:

1. COMBINED CREDIT CLASSES:

Assignment to a stacked class (i.e. a class in which more than one credit programme is being delivered within a period) requires the agreement of the teacher. Hence, school admin should be actively seeking this agreement when such assignments are made and before they are finalized.

2. THREE PERIODS IN A ROW:

Similarly, assignment to a timetable requiring a teacher to teach three periods in a row requires the agreement of the teacher. Again, admin should be actively seeking this agreement when such assignments are made and before they are finalized.

3. LUNCH and PREP:

Every teacher's timetable should indicate a lunch period and a prep period, as well as instructional periods. The lunch period cannot be the first or last period of the school day.
